### Minutes

ENS System Renewal (Moreland) – Cost to renew is \$5,300 to renew for three years. This must be done by November. Moreland asked for this to be deferred to the September meeting, when Barbarich is here to discuss this.

One owner on East Pier got red tagged for building a float. After a month, the county backed off. But they said they would count the float as part of the overall size of the boat, which is not in the code. Moreland will follow this issue.

Bank of Marin closed a loan for 4.12% percent on a floating home. They will have an ad in the tour brochure, and will have a table at the tour.
